CREDIT APPLICATION

Applicant hereby applies for an extension of credit on the payment of freight charges to Commerce Express, Inc. and represents and agrees as follows:

- 1. The person executing this application and agreement is authorized to do so and all statements contained in this application are true and correct.
- 2. The applicant hereby acknowledges that Commerce Express Inc. (a) is operating as a broker of transportation by motor carrier (and not as a motor carrier) duly licensed by the Federal Highway Administration when providing services for shipment by motor carrier; (b) is operating as a shipper's agent when providing services for shipment by rail; and (d) is operating as an air freight forwarder when providing services for shipment by air.
- 3. The applicant agrees: (a) to pay a disbursement fee of 3% of any amounts owed but not paid prior to obtaining cargo releas (i.e.credit shipments); (b) to pay each invoice issued by Commerce Express, Inc. within twenty-one (21) days from the date of the invoice; (c) to pay a 5% late fee on any amount not paid within that twenty-one (21) day period; and (d) to pay a finance charge of 1.5% per month on any amount not paid within that twenty-one (21) period until paid. The day payment is actually received is the date the invoice is considered paid.
- 4. This agreement has been negotiated in the State of Minnesota and that minimum contacts with the jurisdiction of the State of Minnesota have been established. The applicant waives any claim of defense based on jurisdiction and/or venue and does voluntarily submit to the jurisdiction and venue of the State of Minnesota and County of Anoka for all legal issues related to the transaction of business between the parties including, but not limited to, the collection of moneys due pursuant to this agreement.
- 5. If the applicant breaches any term of this agreement including the payment of moneys due pursuant to this agreement, applicant shall pay all costs incurred by Commerce Express, Inc. in enforcing the terms of this agreement including, but not limited to, reasonable attorney's fees, whether or not legal proceedings are commenced.
 - 6. Customer agrees that Commerce Express, Inc. may assert a lien against any shipment, if the customer, or any parent, subsidiary, agent or affiliate of the customer, has failed to timely pay its lawful charges for any other shipment tendered by such customer, its parent, subsidiary, agent, vendors, customers, or affiliates.
- 7. If the applicant incurs a loss or damage claim, the applicant agrees to make a timely claim against the carrier for such loss or damage and agrees not to off-set all or any part of such claim against any amounts due to Commerce Express, Inc.
- 8. Applicant does hereby agree that they have granted Commerce Express, Inc. and its representatives, prior written permission to send advertising or solicitation faxes, emails, letters, telephone calls or other items of a similar nature.
- 9. In the event that Commerce Express, Inc. deems it necessary to utilize the service of a collection agency or attorney to collect any amounts due, applicant agrees to pay all collection costs, attorney fees, and court costs.
